<u>Telephones</u>: We have been informed that we need to move our phone system to a supplier that's on the 'Telephony Better Purchasing Framework (BPF)' this has come in from NHS England, and the framework will be built around the following capabilities defined by the NHS:

- auto-attendant and Interactive Voice Response (IVR)
- call reporting
- call recording
- office telephony
- video consultation

We originally thought our current supply the Bolton Foundation Trust / Virgin /Cisco would be ok and we would be able to stay with them. Unfortunately they were unable to get on to the Better Purchasing Framework in time. As a result, going forward we would not comply with the new requirements set by NHS England. We are now looking at Demos of various companies and we need to make this decision by the end of June.
